## REQUEST FOR PROPOSALS CONSULTANT TO PROVIDE ANALYSIS AND GUIDANCE ON FOSSIL FUEL REDUCTION & ALTERNATIVE ENERGY OPPORTUNITIES DISTRICT WIDE

#### **PURPOSE:**

The purpose of this Request for Proposals ("RFP") is to solicit proposals from qualified consulting firms or individuals ("Consultant") to provide technical assistance to the Peoria Park District ("PPD") in identifying, prioritizing, and sequencing viable and impactful projects and purchases that reduce the PPD's reliance on fossil fuels through the use of base and bonus incentives available through the Inflation Reduction Act ("IRA") and other grant and funding opportunities.

#### **BACKGROUND:**

About the Peoria Park District:

The oldest Park District in Illinois, the Peoria Park District (officially the Pleasure Driveway and Park District of Peoria, IL) was formed in 1894, and today encompasses close to 9,000 acres of land. Within that acreage, the Peoria Park District has 10 major parks, 20 neighborhood parks, several recreation centers, numerous buildings, and a significant amount of conservation land.

In recent years, the PPD has completed several building energy audits, established strategic pillars as guidance for the District concerning environmental conservation, installed rooftop solar, purchased battery powered maintenance equipment and hybrid vehicles, and continues to strive to do more.

#### **SCOPE OF WORK:**

- 1. Assessment of the PPD's current energy consumption, holistically, as well as by location.
- 2. Work with staff to create a summation of PPD's current and past efforts to reduce reliance on fossil fuels.
- 3. Conduct on-site visits to all relevant locations to assess existing infrastructure, energy usage patterns, and potential for renewable energy integration.
- 4. Analyze data and information gathered to identify viable opportunities for renewable energy deployment.

- 5. Evaluate the financial viability and return on investment for each proposed initiative.
- 6. Consider creative approaches to maximize impact and advocate for renewable energy efforts locally and regionally.
- 7. Provide recommendations for integrating renewable energy into long-term organizational plans, taking in to account financial sustainability and advocacy goals.
- 8. Provide list of IRA incentives (both base and bonus incentives) available to non-profits/units of local governments similar to the PPD.
- 9. Identify other grants and funding streams available that have the potential to work in conjunction with the IRA incentives.
- 10. Work with staff to identify commodity purchase needs as well as capital project needs to find opportunities for PPD to benefit from the IRA and other grants in completing these purchases/projects (on-site solar, wind, EV charging, purchase of EVs and clean energy equipment, other clean energy technology, etc...).

#### **DELIVERABLES:**

The Consultant will deliver the following within 6 months of award:

- Comprehensive assessment report outlining findings, opportunities, and prioritized recommendations.
- Financial analysis and projections for proposed renewable energy initiatives.
- Presentation of findings and recommendations to appropriate staff and Park Board committees.
